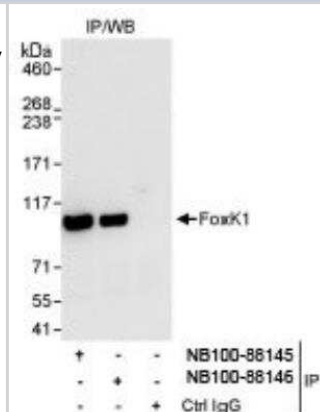

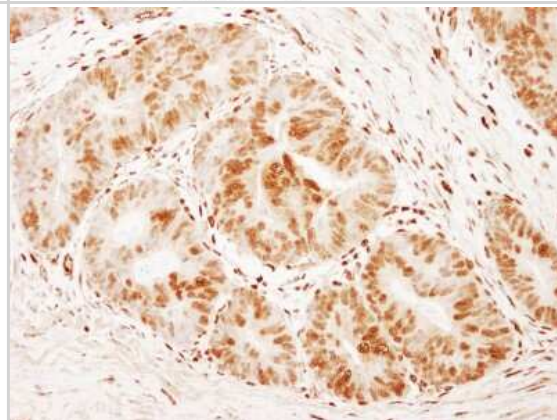

Western Blot: FoxK1 Antibody [NB100-88145] - Immunoprecipitates. Whole cell lysate (1 mg for IP, 20% of IP loaded) from HeLa cells. Affinity purified rabbit anti-FoxK1 used for IP at 3 mcg/mg lysate. FoxK1 was also immunoprecipitated by another rabbit anti- FoxK1 antibody which recognizes a downstream epitope.
