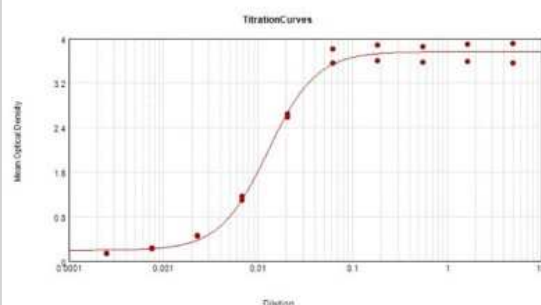

Description	<p>Store vial at 4C prior to restoration. For extended storage aliquot contents and freeze at -20C or below. Avoid cycles of freezing and thawing. Centrifuge product if not completely clear after standing at room temperature. This product is stable for several weeks at 4C as an undiluted liquid. Dilute only prior to immediate use.</p> <p>This product was prepared from monospecific antiserum by immunoaffinity chromatography using Goat IgG coupled to agarose beads followed by solid phase adsorption(s) to remove any unwanted reactivities. Assay by immunoelectrophoresis resulted in a single precipitin arc against anti-Peroxidase, anti-Rabbit Serum, Goat IgG, Goat IgG F(ab')₂ and Goat Serum</p>

This product has been assayed against 1.0 ug of Goat IgG in a standard capture ELISA using ABTS (2,2'-azino-bis-[3-ethylbenthiiazoline-6-sulfonic acid]) as a substrate for 30 minutes at room temperature. A working dilution of 1:8,000 to 1:62,000 of the reconstitution concentration is suggested for this product.</p> <p>NOTE: Do NOT add Sodium Azide (it inhibits HRP irreversibly).</p>

ELISA: Rabbit anti-Goat IgG F(ab')₂ Secondary Antibody [HRP] (Pre-adsorbed) [NBP1-73575] - ELISA results of purified Rabbit anti-Goat IgG F(ab')₂ Secondary antibody [HRP] (Pre-adsorbed) tested against purified Goat IgG F(ab')₂. Each well was coated in duplicate with 1.0 ug of Goat IgG F(ab')₂. The starting dilution of antibody was 5ug/ml and the X-axis represents the Log₁₀ of a 3-fold dilution. This titration is a 4-parameter curve fit where the IC₅₀ is defined as the titer of the antibody. Assay performed using TMB substrate.
