Specificity/Sensitivity	Assay by immunoelectrophoresis resulted in a single precipitin arc against anti-Human IgG, anti-Human IgG F(ab)2 and anti-Human Serum. No reaction was observed against anti-Human IgG F(c) or anti-Pepsin.
Notes	No test method can provide total assurance that the hepatitis B virus, hepatitis C virus, human immunodeficiency virus, or any other infectious agents are absent.
