Description	This Sheep IgG F(ab) immunoglobulin is useful as an isotype control for Sheep IgG F(ab) antibody.

Specificity/Sensitivity	No reaction was observed against anti-Sheep IgG F(c) or anti-Pepsin.
Notes	This product was prepared from normal serum by delipidation, salt fractionation, ion exchange chromatography followed by pepsin digestion and extensive dialysis against the buffer stated above. Assay by immunoelectrophoresis resulted in a single precipitin arc against anti-Sheep IgG, anti-Sheep IgG F(ab')₂ and anti-Sheep Serum Store vial at 4C prior to restoration. For extended storage aliquot contents and freeze at -20C or below. Avoid cycles of freezing and thawing. Centrifuge product if not completely clear after standing at room temperature. This product is stable for several weeks at 4C as an undiluted liquid. Dilute only prior to immediate use.
