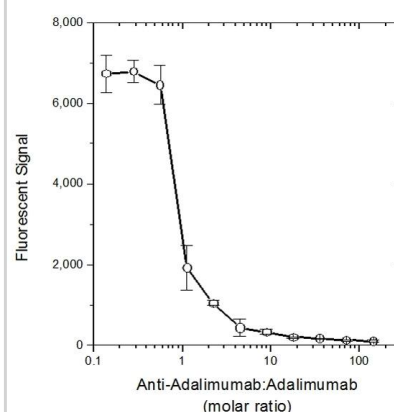

No reactivity is seen with the Fc portion of human IgG or non-immunoglobulin serum proteins.
