Reactivity Notes	Mouse. Minimum reactivity to human and rat.
Specificity/Sensitivity	Antiserum was solid phase adsorbed to ensure class specificity. Antiserum was cross adsorbed using human and rat immunosorbents to remove cross reactive antibodies. The antibody to mouse F(ab') ₂ was isolated by affinity chromatography using antigen coupled to agarose beads. F(ab') ₂ fragments were generated using a pepsin digestion. Fc fragments and whole IgG molecules have been removed. Fragments were conjugated to R-phycoerythrin (RPE). Antibody concentration was determined by extinction coefficient: absorbance at 280 nm of 1.4 equals 1.0 mg of IgG. By immunoelectrophoresis and ELISA this antibody reacts specifically with mouse F(ab') ₂ . No antibody was detected against non-immunoglobulin serum proteins. Less than 1% cross reactivity to human and rat F(ab') ₂ was detected. This antibody may cross react with F(ab') ₂ from other species.
