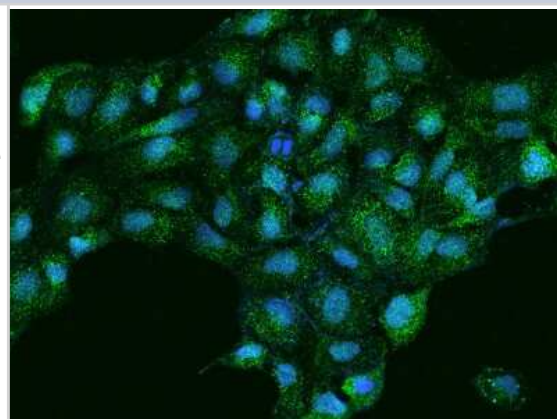

Immunocytochemistry/Immunofluorescence: EPS8L3 Antibody [NBP2-98054] - Immunofluorescence staining of EPS8L3 in U2OS cells. Cells were fixed with 4% PFA, permeabilized with 0.1% Triton X-100 in PBS, blocked with 10% serum, and incubated with rabbit anti-Human EPS8L3 polyclonal antibody (dilution ratio 1:200) at 4C overnight. Then cells were stained with the Alexa Fluor(R)488-conjugated Goat Anti-rabbit IgG Secondary antibody (green) and counterstained with DAPI (blue). Positive staining was localized to Cytoplasm.
