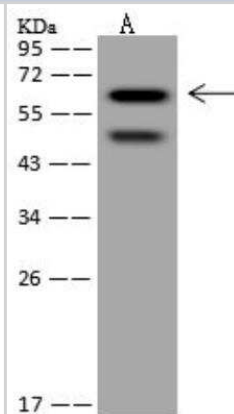

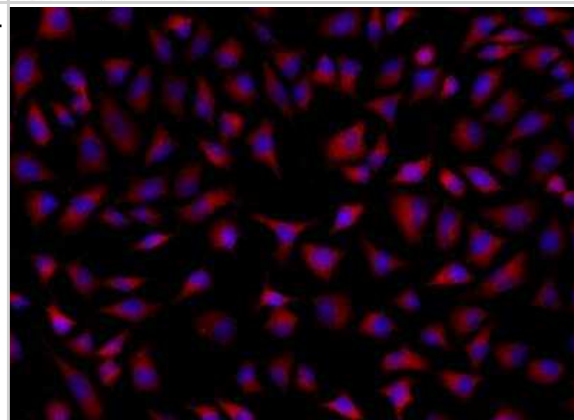

Western Blot: SRCRB4D Antibody [NBP3-12628] - Lane A: HepG2 Whole Cell Lysate Lysates/proteins at 30 ug per lane. Secondary Goat Anti-Rabbit IgG (H+L)/HRP at 1/10000 dilution. Developed using the ECL technique. Performed under reducing conditions. Predicted band size:61 kDa Observed band size:61 kDa (We are unsure as to the identity of these extra bands.)



Immunocytochemistry/Immunofluorescence: SRCRB4D Antibody [NBP3-12628] - Staining of SRCRB4D in Hela cells. Cells were fixed with 4% PFA, permeabilized with 0.1% Triton X-100 in PBS, blocked with 10% serum, and incubated with rabbit anti-Human SRCRB4D polyclonal antibody (dilution ratio 1:200) at 4°C overnight. Then cells were stained with the Alexa Fluor®594-conjugated Goat Anti-rabbit IgG secondary antibody (red) and counterstained with DAPI (blue). Positive staining was localized to Cytoplasm.
