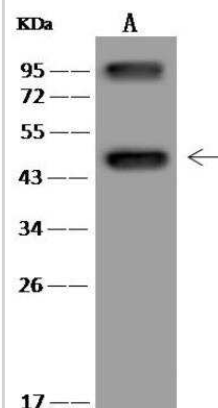

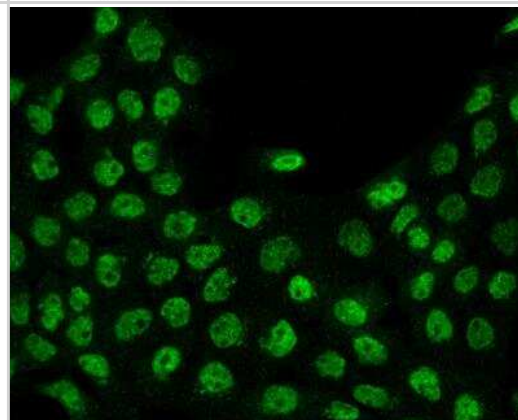

Western Blot: FCHSD1 Antibody [NBP3-12654] - Lane A: MCF7 Whole Cell Lysate Lysates/proteins at 30 ug per lane. Secondary Goat Anti-Rabbit IgG (H+L)/HRP at 1/10000 dilution. Developed using the ECL technique. Performed under reducing conditions. Predicted band size:46 kDa Observed band size:46 kDa (We are unsure as to the identity of these extra bands.)



Immunocytochemistry/Immunofluorescence: FCHSD1 Antibody [NBP3-12654] - Staining of FCHSD1 in A431 cells. Cells were fixed with 4% PFA, permeabilized with 0.3% Triton X-100 in PBS, blocked with 10% serum, and incubated with rabbit anti-Human FCHSD1 polyclonal antibody (dilution ratio 1:200) at 4°C overnight. Then cells were stained with the Alexa Fluor®488-conjugated Goat Anti-rabbit IgG secondary antibody (green). Positive staining was localized to Nucleus.
