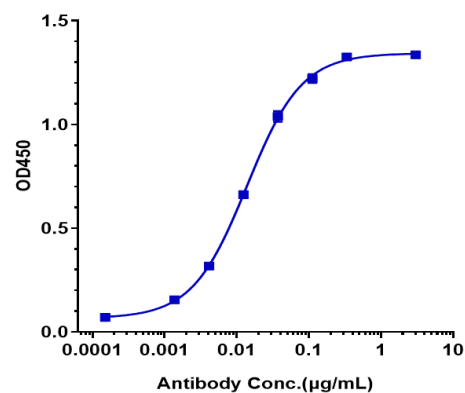

Avoid repeated freeze-thaw cycles.
